Responsibilities

Remit

To oversee:

- the school's contribution to pupil well-being, their behaviour and safety, including promotion of healthy lifestyles and contribution to the school and wider community;
- 2 the maintenance and promotion of parental and community engagement.

Care

- 3 Keep under review policies designed to promote good behaviour and discipline and associated policies*, monitor their implementation and evaluate outcomes.
- 4 Monitor attendance and evaluate strategies designed to maximise it
- Keep under review any trends in pupil exclusions and strategies designed to minimise exclusions.
- 6 Review annually, monitor and evaluate the effectiveness of safeguarding procedures, including the *Child protection policy*, and make recommendations to the governing body to address any emerging issues.
- 7 Keep under review the way in which pupil views are taken into account, including the school council.
- 8 Monitor and evaluate the welfare requirements of the Early Years Foundation Stage.

Communication

- 9 Monitor the range of the extended school offer including after school clubs, school performances and visits and evaluate its impact.
- 10 Gauge opinion of parents and pupils by preparing surveys including an annual questionnaire.
- 11 Monitor and evaluate the engagement of parents with the school, parental views and how these are taken into account and consider ways in which homeschool links can be further
